

Romney for President, 2007-2008

If you were to ask Mitt Romney questions, begin by making a three part question, followed by others:

Mr. Romney, you want to represent the majority of American voters, including Mormons. Please clarify yourself by answering these first three simple questions.

1. In the front of your *Book of Mormon* it says that it "is **the most correct book on earth.**" Do you agree? (Let him answer.)
2. Do you testify that the *Book of Mormon* is your **guide for life and that it is true?** (Let him answer.)
3. Is *The Book of Mormon* wrong for saying in 1 Nephi 14:10, and in numerous other places, that **all non-Mormon churches are an abomination and the whore of the whole earth?** (Let him answer.)

Other Questions:

4. How are you going to represent the American voter when you testify that your church's Prophet, Joseph Smith, is a true Prophet of God and **you have pledged yourself to Smith's Temple rites by secret oath**, one of which may include death to yourself for not complying? (D&C 132:26, JG, Journal of Discourses, Vol. 4, Pg. 49-51; BY, Journal of Discourses, Vol. 4, Pg. 53-54)
5. You say you believe in the Christian's *Bible*, but in fact only believe parts of it. **Is your unclear way of stating your belief meant to confuse or deceive voters, or is it a political strategy?** (Romney, CBS-TV, Texas, 12-8-2007)
6. Though the Mormon Church has now accepted Blacks, the children of Cain, into their Priesthood, still the *Book of Mormon* is extremely **racist** against them, and yet it still remains your "most correct book on earth." Will you as President say one thing and do another and tell us you are not in conflict with yourself, our people and our laws? (Journal of Discourses, Vol. 2, Pg 143, Vol 7, Pg 290-91, J F Smith Answers to Gospel Questions, Vol. 2, Pg 188, Alma 3:6-9, 2 Nephi 5:21-24)
7. As a Mormon, **plural marriage** is one of the most important doctrines ever revealed to man in any age of the world, according to your prophet Joseph F. Smith. Without polygamy, Mormons can never be exalted to become gods. Presently, **polygamy** is outlawed and if you, a Mormon, become President, do you intend to try to lead America back into polygamy for the Mormon's self-serving purpose, for their hope to legally marry many wives, to become individual Mormon gods, for becoming multiplying fathers in their own individual worlds? (D&C 131:1-8)
8. There is a Mormon doctrine of **Blood Atonement**. To summarize it, Mormons believe that there are sins that the blood of their Jesus Christ cannot atone for. Mormonism says that the person behind the sin must atone for his own sin, which can include the shedding of his own blood. This may tempt a Mormon President to cause blood to be shed unjustifiably, or untimely, based upon the President's underlying belief in his Mormon religion. Is this a rare possibility? 9. **The Jesus Christ of Mormonism**, per your present Church Authority, Prophet, Gordon Hinckley, is not the Jesus Christ of Christianity. Why are Americans led to believe they are the same by you and other Mormons in this campaign? Is it because of a Mormon's allegiance to his, or her, **forever secret temple oaths** taken in front of Church Authorities? (8-1-96, BYU-TV #9397)
10. In your "most correct book on earth," *The Book of Mormon*, it says that our fellow citizens, the **American Indian is not a "white man"** because he is a loathsome sinful person whose racial characteristics will not change, unless he repents before Mormonism's god. How will you fairly represent our American Indian voters? (2 Nephi 5:21-25, Enos 1:20)
11. **Freedom of Religion** itself is not a Presidential qualification, nor are these questions meant to violate any Mormon's right to their freedom to practice their Mormon religion, but do you see why these questions are relevant to non-Mormon people when they are choosing a President who is to represent all the American people? (United States Bill of Rights)

Several More Questions that Christian Voters Might Ask

1A. America is one diverse racial family. As a Mormon, you promise us "**Families Together Forever.**" Yet when one logically studies that Mormon statement in detail, there is no such thing. 3A. To date, you have publically focused upon the general principles of religious freedom. Yet, religion influences any person's perspective and actions to some degree. Decision making is of concern to every voter. Mormonism was founded by Joseph Smith who put stones into a hat, followed by his face, to make *The Book of Mormon*. Have you made governmental decisions by this or similar methods?

Summary

These questions are relevant to our upcoming political election. But to many people, they may sound biased. Both are true to some degree, only because these questions are intended to reveal truth that is deceptively being perpetrated upon the unsuspecting American voter. Freedom of Religion is not intended to be violated, but when you consider the depth of inquiry these questions ask, they expose very serious faults in a Mormon's qualifications to become President of the United States.

Mormons claim their book of faith, *The Book of Mormon*, is above all books in the world and is the "most correct book on earth." Just any simple math book proves that statement of faith to be false, but Romney has testified again and again, publicly, that their statement is true.
